Following the December 5 magnitude 5.9 earthquake that struck Lubang, Occidental Mindoro and other parts of Luzon including Calabarzon and Metro Manila, PTT Philippines' Business Continuity Management (BCM) has immediately convened a corporate earthquake drill to refresh employees on what to do when another quake strikes. PTT Philippines Corporation President & CEO Khun Sukanya Seriyothin called for an immediate meeting with the BCM to hold a corporate-wide earthquake drill for its Makati, Quezon City, Subic and Clark offices. She instructed Corporate Support Director Paul Senador and the QSHE Department to lead a simulation drill for a 7.5 magnitude quake in a situation where the Makati office is inaccessible and designating the Edsa Veterans Training Center office as back-up office. "It is important to remind our staff and everyone in the office on what to do under this kind of situation," said Seriyothin who for several times had experienced earthquakes while in the office which happened to be on the 32nd floor of a tower building in Makati. Meanwhile, Mr. Senador said the drill was aimed at gauging the response capability of each location an determine the critical business functions and the return-time-objective of each Department to resume at least 50 percent of the business operations capacity.





QSHE holds emergency drill at Cubi Facility



The QSHE Department has conducted an Emergency Drill at Cubi Aviation Facility under a certain emergency scenario to develop the response capability of personnel. The December 19 drill involved QSHE, Aviation, Clark, Depot, Engineering Operations, including personnel from Maintenance and AMIKE Security Services. QSHE's Reymond Dimitui said the emergency drill was conducted under an oil spill scenario, fall incident rescue, and fire incident. "We are regularly doing this as part of awareness and knowledge development of assigned personnel and ECC members in responding to different scenario," Assistant Manager for QSHE Jose Solomon said, adding that it allows them to determine the response time during emergency and help identify gaps and areas for improvement.

Environmental consultant cites importance of EPR Law



An environmental consultant has emphasized the significance of managing the solid waste and encouraged PTT Philippines to get a grip of Extended Producer Responsibility (EPR) on plastic packaging waste. In a recent webinar for QSHE and PTT Philippines' top management, Atty. Zoilo Andin, Jr. said understanding the EPR Law (Republic Act 11898) and its principle can significantly enhance solid waste management of any company like PTT. RA 11898 institutionalizes the EPR on Plastic Packaging Waste and amends for this purpose Republic Act 9003 or the Ecological Solid Waste Management Act of 2000. The EPR Act took effect on August 12, 2022. It requires obliged enterprises (OEs), by themselves or collectively, with or without Producer Responsibility Organization (PRO), to prepare and register with the National Solid Waste Management Commission, through the Department of Environment and Natural Resources, their EPR Programs to reduce and/or recover for reuse, recycling, treatment, or proper ecological disposal the plastic packaging waste that they release or released to the domestic market.

PTTPFI's 'Mission of Hope' brings joy to 200 kids from children centers



Around 200 children from different shelters in Central Luzon have received some gift packs from PTT Philippines Foundation, Inc.
